# CALL TO ORDER AND ROLL CALL FOR REGULAR SCHEDULED BOARD MEETING

The Regular Meeting of the Board of Kewanee Community Unit School District No. 229 was held in the Kewanee High School Petersen Auditorium with President Johnson calling the Meeting to order at 6:00pm. # **INVITED GUESTS**

## Greg Wertheim-Henry/Stark Special Education District Director

Greg Wertheim, Henry Stark Special Education Director, stated that he tries to visit each District each year. Mr. Wertheim gave the Board the historical numbers of special education students for the District. The District consistently has 18% of its students qualify for special education services. These numbers include speech services. The State average of students being served is 14%. Mr. Wertheim stated that when ESSER funds were dispersed, Henry/Stark received \$1,000,000. He allocated those funds to the Districts within the Co-op based on enrollment numbers. Dr. Sullens stated that the District was planning on using the approximately \$400,000 it receives to build the addition at Lyle School. Mr. Wertheim stated he felt the funds were being put to good use.

## Kyle Joos and McKenzie Carton-State FFA District 1 Proficiency Winners

FFA Members, Kyle Joos and McKenzie Carton, were honored with Board Resolutions. Kyle Joos received High Honors for his Supervised Agriculture Experiences in Agriculture Mechanics/Maintenance and Repair Placement Proficiency Award. He was unanimously named the Section 3 Winner. This advanced him to compete at District 1 interviews, placing him in the Top 5 at State Awards day in Decatur. Mrs. Baney presented the Board Resolution to Kyle Joos and his advisors, Lexi Ruemker and Kindra Callahan.

McKenzie Carton received High Honors for her Supervised Agriculture Experiences in Food Service Entrepreneurship Profieciency Award. She was named the Section 3 winner, advancing her to District 1 interviews. This placed her in the Top 5 at State Awards day in Decatur. Mrs. Baney presented the Board Resolution to McKenzie Carton and her advisors, Lexi Ruemker and Kindra Callahan.

## KHS Band and Choir-Runner Up in the IHSA Solo Ensemble Organizational Contest Class B

The KHS Band and Choir with their Directors, Alex Binek, Brittany Krohn, and Katie Yelm, were presented a Board Resolution by Mrs. Baney. They were honored for their 2nd Place finish overall in Class B in the IHSA Music Sweepstakes Series with 834 total points. The KHS Band and Choir earned a school record of 534 points and 164 Division 1 Medals at the Solo and Ensemble Contest at Monmouth-Roseville High School. The Organizational Music Contest that was held at Kewanee High School and KHS participants scored a state maximum of 300 points. The Board Resolution was presented for their outstanding achievement and success during the season.

Before Mrs. Baney presented the Board Resolution to the KHS Band and Choir, Senior members of the Band presented the School Board and Dr. Sullens with Honorary Class B Runner-up IHSA medals.
