## **KEWANEE COMM SCHOOLS BOARD OF EDUCATION MEETING MAY 16, 2022**

#### CALL TO ORDER AND ROLL CALL FOR SPECIAL BOARD MEETING

The Regular Meeting of the Board of Kewanee Community Unit School District No. 229 was held in the Kewanee High School Petersen Auditorium with President Johnson calling the Meeting to order at 6:00pm. Roll call showed the following Members present: Stabler, Dev, DeBord, Christiansen, Salisbury, Steffen, and Johnson. Superintendent Sullens was also present for the Closed Session.

# **EXECUTIVE SESSION OF SPECIAL BOARD MEETING**

## REPORT FROM ADMINISRATION

# Superintendent

Congratulations to our Retirees- Christopher Gustafson, Bill Pann, and Laura Greenhagen

Dr. Sullens congratulated retirees Christopher Gustafson, Bill Pann, and Laura Greenhagen. Chris Gustafson is a longtime Kewanee #229 teacher, assistant principal, and coach. Laura Greenhagen is a longtime employee in the

District cafeteria. Bill Pann was a longtime bus driver. Dr. Sullens wishes them the best in their retirement.

# Summer Food Program Sites: Central School, KHS, Neponset Grade School, Belle, Irving, Lyle, YMCA, Fairview Homes, & Reagan Townhouses

Dr. Sullens stated that once again the District will be offering free breakfasts and lunches over summer break. The locations serving meals this year include Central School, KHS, Neponset, Belle, Irving, Lyle, Fairview Homes, Reagan Townhouses, and the YMCA. Free meals are available to anyone under 18 years old.

# Review of 2021-2022 Budget

Dr. Sullens informed the Board that the FY 22 budget will be amended. The ad will appear in the paper this week. With the budget, Dr. Sullens stated that at the beginning of the year we estimate our income and expenses. This year we will need to amend to budget for the ESSER III dollars and what will be spent within this fiscal year. The projects that are being voted on tonight won't be paid until FY23.

#### Evidence Based Funding-\$200,937 (June 2022)

Dr. Sullens informed the Board that we are expecting a check for \$200,937 from the State Board of Education. This amount is what we were shorted due to an enrollment coding error in the EBF formula. The funds are expected to be received before June 30<sup>th</sup>.

# Excess Soil from KHS Turf Project/Discussion of Park District/Sale of Soil/Retention of Soil

Dr. Sullens updated the Board on the upcoming turf and lighting projects. Dr. Sullens stated that May 23 the process of installing the new lighting will begin. Next week Byrne and Jones will begin to remove the top soil from the football field. Dr. Sullens and JR Salisbury have been in contact over the phone and Skype with the project manager. Initially it was believed that we would have approximately five inches of good top soil. Now it is believed that it could be upwards of ten to twelve inches. The turf committee came up with ideas of uses for the excess top soil. The decision to offer the soil to the Park District came from current state of the soccer field. Currently, teams won't play Kewanee because they don't feel that the field is suitable to play on. Referees have threatened to report the field to the IHSA. Dr. Sullens stated that he and JR Salisbury have spoken with Andy Dwyer, Park District Director. Dr. Sullens and Member Salisbury attended the May Park District Meeting to pitch their offer. The offer stated that if the School District gave the Park District top soil worth approximately \$50-60,000 that in return the annual fees paid to the Park District wouldn't increase for ten years.

After meeting with Park Board members, Dr. Sullens stated that the feeling he got was that they aren't interested in going through with the project. Dr. Sullens stated that the Park Board has a meeting this coming Thursday, but believes that it is best to move on.

President Johnson stated that he is disappointed in the lack of interest. He believes that with cooperation both organizations would gain and the taxpayers would benefit.

Member Salisbury stated that he believes when two taxing bodies are working together that it is a win-win for the taxpayers.

## Foundation - Dual Credit

Dr. Sullens stated that the Foundation held the 30 Trips for 30 Years event at Midland Golf Club. The sold out event was a fundraiser to support Dual Credit Scholarships.

### Foundation Video

Dr. Sullens informed the Board that the video that was shown at the Foundation's fundraiser will be on either the District's or Foundation's website soon. Dr. Sullens also stated that the District plans to create additional videos for the website highlighting new additions to the District.

## Presentation 2022 Board Convention

Dr. Sullens shared that the District and the Kewanee Schools Foundation have been selected to present at the IASB Conference in Chicago this November. The presentation at the Share the Success panel will highlight the successes of the Kewanee Schools Foundation. President Johnson stated that over 80 applicants had submitted ideas to present and out of those applicants Kewanee Schools was chosen. President Johnson stated that Liz Breedlove is working hard on the presentation.

# **Update on Property Tax Bills**

Dr. Sullens stated that tax bills were sent out for Henry County and will be coming soon for Bureau County. Dr. Sullens informed the Board that due to errors from both courthouses the estimated assessed value was off. Therefore, the District figures were off a little. This will lead to a savings for the taxpayers. Next year the EAV for Henry County could be affected by the installation of wind turbines in the area.

## Dr. Tammy Brown-Title III-Received Special Notification from ISBE (Miler, Diaz, Comer, Guerrero)

Dr. Sullens wanted to announce that Dr. Brown and the District ELL staff have been recognized the State Board of Education for their work with ELL students. The District ELL staff includes Mrs. Comer, Mrs. Diaz, Mrs. Miler, and Ms. Guerrero.

#### Avagrid-Midland-Wind Farm Project

Dr. Sullens stated that Avagrid-Midland will be installing wind turbines in the area. Thirteen will be installed in the Kewanee #229 District, twelve within Galva's school district, and one in Annawan's school district. District staff is working to estimate when the wind turbines will be added to the county EAV.

#### Mrs. Hodge-Bates-Neponset Principal

#### Title I Annual Review Report

Mrs. Hodge-Bates presented the Annual Title Plans to the Board. The Title I Plans includes one Consolidated District Plan as well as individualized plans for each of the buildings. The Board was given an overview of how the Title funds were spent over the past year. Mrs. Hodge-Bates stated that funds were used to support the newly implemented curriculums, interventions, professional development, and SEL programs. Mrs. Hodge-Bates also reviewed the Parental Involvement Policies. Building policies are individualized and developed by staff within each building.

# Neponset Track Sectional Update

Mrs. Hodge-Bates stated that Sectionals were held on May 6<sup>th</sup>. She informed the Board the even though no one qualified for State, athletes performed well. Ashley Luna placed 2<sup>nd</sup> after losing in a jump off in the 7<sup>th</sup> grade high jump.

## **KHS Sports Update**

Mr. Atwell gave the Board an update of the spring sports at KHS. Girls Track had two athletes qualify for the State meet the weekend of May 20<sup>th</sup>. Larissa Meyer qualified in the High Jump and Makenna Peed qualified in the Shot, Discus, 100m, and 200m in the wheelchair division. The Boys Track team will compete at the Metamora Sectional on May 18<sup>th</sup>. Girls Softball played in the Quarterfinal game tonight (May 16<sup>th</sup>). They won 18-0 over Hall. They will play May 18<sup>th</sup> against Sherrard. Baseball will play in the Regional Semifinal on May 18<sup>th</sup>. KHS will play the winner of the Alleman and Sherrard game. Mr. Atwell stated that Emma Crofton broke the school record in the Triple jump at the Geneseo Sectional. Xander Gruszeczka was the lone conference champion at the Three Rivers Conference Meet. He won in the Pole Vault event. Mr. Atwell stated that the Brockman Invitational this year was cancelled due to weather. Even with the cancellation the King and Queen were named. This year Jamiha Israel was named Queen and Niko Powe was named King.

## Mr. Bryan - KHS Principal

#### KHS Prom and Graduation

Mr. Bryan stated that students were able to have a traditional Prom this year. The students enjoyed the event. Mr. Bryan informed the Board that 118 graduates walked across the stage for Graduation this year. He stated that with all that the kids have been through the last couple of years, it was nice to have a traditional graduation ceremony. At graduation this year \$118,000 in scholarships were given out. Mr. Bryan wanted to thank the Foundation and the community for their support.

## Mrs. Callahan and the KHS FFA Chapter

Mr. Bryan informed the Board that the KHS FFA Chapter was honored as a Gold Program. The KHS FFA Chapter is one of 35 Chapters in the State to receive the honor. Five KHS students earned their FFA State Degrees. They include Mercedes Hasbrook, Ryan Kilstrom, Brendon Mason, Preslee Weida, and McKenzie Carton. Dr. Sullens added that the FFA banquet this year was phenomenal. They had 131 people in attendance, including industry leaders and Alumni.

Mr. Bryan also informed the Board that Mrs. Callahan was named the winner of the Teachers Turn the Key Scholarship. Mr. Bryan stated that more information will be released at later date. Mr. Bryan stated that Mrs. Callahan's hard work, dedication, and enthusiasm is shown in the KHS Agriculture Program.

# Mr. Anderson- Central Principal

Mr. Anderson informed the Board that the 8<sup>th</sup> Grade Promotion was on May 19<sup>th</sup>. He also wanted to spotlight the State Qualifiers from the Central Junior High Track team. Anthony Padilla qualified in the hurdles, Nolie Charlet in the 800m, and Jendayia Crowe in the High Jump. The 4X100 relay team also qualified. The team consists of Jendayia Crowe, Dani Jo Currier, Kolbie Cernovich, and Kalei Rice. The State meet is the weekend of May 20<sup>th</sup>.

## Mrs. Philhower-Star Courier Teacher of the Year

Mr. Anderson informed the Board that Mrs. Philhower was named the Star Courier Teacher of the Year. Mr. Anderson stated that she is a phenomenal teacher who helps wherever is needed. She is also the elementary PBIS Coordinator. The Star Courier received eighteen letters from current and past students.

## Central Strawberry Festival and Art Fair

Mr. Anderson stated that it was great to have the Strawberry Festival back this year. It was so popular that they sold out. Mr. Nelson had the Art Fair setup in Steamer Gym.

The addition at Neponset is to create a STEAM room, restrooms, and a pre-k classroom to replace the existing temporary building. The temporary building was installed for pre-k in 1996. The District will be using ESSER III and local funds to pay for the project. The bids came in at three million
